

Shareholder Communication

Policy

POL-LGR-GNP-0009

1. Purpose

- a. GenusPlus Group Limited (GNP) recognises that shareholders and other stakeholders are entitled to be informed in a timely and readily accessible manner of all major developments affecting GNP.
- b. The purpose of this Shareholder Communication Policy is to promote effective communication with shareholders and to encourage and facilitate participation at GNP's general meetings and dealing promptly with the enquiries of shareholders.

2. Methods of Communication

Information is provided to shareholders through, but is not limited to:

- a. Releases to the Australian Securities Exchange (**ASX**) in accordance with continuous disclosure obligations.
- b. The investor relations section of GNP's website (www.genus.com.au).
- c. GNP's annual and half-yearly reports; and
- d. The annual general meeting (AGM).

GNP encourages shareholders to receive company information electronically by registering their email address online with GNP's share registry.

3. ASX Releases

- a. GNP will make announcements to the ASX in a timely manner in accordance with the ASX Listing Rules (see also, GNP's Disclosure Policy).
- b. All announcements made to the ASX are available to shareholders:
 - i. Under the Investor Relations section of GNP's website; or
 - ii. Under the company announcements section of the ASX website.

4. GNP's Website

- a. The **Investor Relations** section of GNP's website is the primary medium of providing information to shareholders and stakeholders. It has been designed to enable information to be accessed in a clear and readily accessible manner.
- b. The **Investor Relations** section of GNP's website will contain information relevant to shareholders and stakeholders including statements lodged with the ASX by GNP (including all financial results and annual reports), press releases and other material relevant to GNP shareholders.
- c. Details on the board of directors of GNP (**Board**) and Board committee charters and corporate governance policies can be found under the **Who We Are** section of the website (www.genus.com.au).

d. Shareholder and stakeholders can also contact GNP via its website under the "Contact" tab of GNP's website.

5. Annual General Meeting

- a. The (AGM) provides an important opportunity for GNP to provide information to its shareholders and a reasonable opportunity for informed shareholder participation. At the AGM, shareholders will have a reasonable opportunity to express their views to the Board and management and to vote on the Board's proposals. All shareholders are encouraged to attend the AGM.
- b. The date, time and location of the AGM will be provided in the notice of meeting and on GNP's website.
- c. Where practicable, GNP will consider the use of technological solutions for encouraging shareholder participation at meetings (which may include, for example, live webcasting of meetings, holding meetings across multiple venues by live telecommunications and hybrid meetings).
- d. The notice of meeting and proxy form will be distributed to all shareholders prior to the AGM in the timeframe set by the Corporations Act and will be available on GNP's website.
- e. GNP's auditor attends its AGM and is available to answer any questions regarding the conduct of and any issues arising from the audit or the preparation and content of the auditor's report.

6. General

a. Annual report:

Unless the share registry has been notified otherwise, the annual report will be emailed to all shareholders (to the email address recorded on GNP's share register) prior to the AGM and within the timeframe set by the Corporations Act.

b. Half-year and full-year results:

The half-year and full-year results will be announced to the ASX pursuant to the ASX Listing Rules and are available to shareholders in the same manner as other ASX announcements. Following the release of GNP's half-year and full-year results, GNP may conduct investor and analyst briefings at which the media, institutional investors and stockbroking analysts will be briefed and given an opportunity to ask questions of the Managing Director, Chief Financial Officer, and other relevant members of management.

c. Dividends:

Australian resident shareholders are encouraged to provide GNP's share registry with bank account details to enable GNP to pay dividends by electronic funds transfer, rather than by cheque.

e. Shareholder enquiries:

GNP is committed to dealing with shareholder enquiries promptly and courteously and takes measures to ensure that its registry also does so.

f. Shareholders' meetings:

GNP will ensure that all substantive resolutions at a meeting of shareholders are decided by a poll rather than by a show of hands.

g. Shareholder privacy:

GNP recognises that privacy is important and will not disclose registered shareholder details unless required by law. Shareholder details will only be used in accordance with applicable privacy laws. A copy of GNP's privacy policy is available on GNP's website.

Review and Changes to this Policy

- a. The GNP Disclosure Committee will review this policy periodically or as often as it considers necessary to check it is operating effectively and consider whether changes are required.
- b. The Board may change this policy from time to time by resolution.
